Temporary Special Use Permits are to address critical, short-term parking challenges specific to temporary situations, such as			
construction activities, critical care or events.			
2. Temporary Special Use Permits will be assessed on a case-by-case basis. Availability, number and prioritization of issue of these permits will be dictated by a range of factors including availability of on-street parking, impacted properties and available supply and access to off-street parking. Numbers of permits issued in an area need to consider the local street environment and available legal car park supply to balance parking demand and supply to ensure equitable opportunity to access on street carparking.			
3. Permits exempt the holder from timed parking restrictions in specified areas and allows the holder the opportunity to park close to their residential property but does not guarantee parking availability. The permit does not extend to No Parking, No Stopping, Bus, Taxi and Loading Zones or any other prohibited parking area defined by the Australian Road Rules (1999).			
4. The dwelling unit is the principal place of residence of the applicant.			
5. If a residential property has access to any off-street parking spaces, then that property is not eligible for a temporary special use/ residential parking permit.			
6. Applicants shall produce evidence of vehicle ownership prior to the issue of a permit.			
7. The permit shall be affixed on the left side of the dash, clearly visible from the kerb.			
8. The permit shall only apply within the area defined by the Council and in the manner specified by the Council.			
9. The permit shall only apply until the date shown thereon.			
10. The permit is neither assignable nor transferable and permit holders have no jurisdiction whatsoever in the use of such areas (zones).  The areas are for the sole use of vehicles for which permits have been issued and are clearly displayed.			
11. Permits can only be issued against the registration of a currently unconditional South-Australian registered vehicle which is not a truck (exceeding GVM4500), trailer, caravan, boat, bus, motorcycle, or conditionally registered vehicle.
