Request for Extension of Time Application Form

This form is to be completed when applying to Council for an extension of Development Plan Consent or Development Approval for a Development Application.

As per Regulation 67 of the Planning, Development and Infrastructure (General) Regulations 2017, when a development is granted Development Plan Consent, the applicant has 12 months from the operative date in which to obtain Building Rules Consent. When a development is granted Development Approval, the applicant has 12 months from the operative date to substantially commence the development, thereafter for the development to be either substantially or fully completed within 3 years.

It is recommended that this application be lodged with Council a minimum of twenty (20) business days prior to the lapsing of the Consent/Approval to allow sufficient time to assess the request.

Fees and Charges

A fee of \$116.00 is payable at the time of lodgement of this application. This fee is solely an application charge for the processing of your request. Payment of this fee does not guarantee an approval for an extension of time.
